The grantee shall maintain subsidiary account of the grant-in-aid received from the government. No assets should be created from out of this grant.

The expenditure on account of the above grant is debitable to Demand No.19, Art & Culture, Major Head 2205- Minor Head 00.02, 04 Other Scheme, 04.12-Centenary/Anniversary celebration 04.12.31- grant-in-aid (Non-Plan) **Non-recurring 2009-10**.

The accounts shall be audited by the internal Auditor of grantee by the Comptroller and Auditor General of India under Section 14 of the CAG of India (Duties, Power and conditions of service) Act.1971..

The Organisation has **Account No.007010100379199**, Axis Bank, Statement House, 148, Bara Khamba Road, New Delhi -110001. **The MICR Code No of the bank is 110211002.**

The accounts of grantee institution shall be open to inspection by the Ministry of Culture and audit, both by the Comptroller and Auditor General of India under the provision of AG(DCP) Act. 1971 and Internal Audit by the Principal Accounts Office of the Ministry of Human Resource Development whenever the institution is called upon to do so.

The amount will be drawn by the Drawing and Disbursing Officer (Grants) of the Ministry of Culture and paid by ECS/ to the **Bamongram Resham Khadi Pratisthan Vill & P.O. Bamongram P.S. Kaliachak Distt. Malda West Bengal-732206** No part of this grant should be diverted to any institution or utilized for any other purpose.

10. The grantee shall not divert the grants and entrust execution of the scheme or work concerned to another institution or organization and shall abide by the terms and conditions of the grant. If the grantee fails to utilize the grant, for the purpose for which the same has been sanctioned, the grantee will be required to refund the entire amount with interest thereon @ 10% per annum.

11. The organization shall be bound to submit from time to time such reports, statement etc. in respect of expenditure from this grant as might from time to time required by the Government of India.

12. It is further certified that the grant-in-aid is sanctioned in accordance with the pattern of financial assistance approved by Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by that Ministry.

13. The grant-in-aid is further subject, to the conditions laid down in General Finance Rules as amended from time to time.

14. The sanction is issued in exercise of the delegation powers in consultation with **Integrated Finance Division (IFD) vide their Dy.No.2231/IFD/2009 dated 31.10.2009 and funds is certified by online vide their Dy. No.522 dated 17.11.2009.**
