Madam/Sir,

With reference to your letter dated 18/07/2012 I, I am directed to inform you that you have applied to conduct Research Studies on **Ostracization of women as Witches its causes compensation to victimized women and life after**. The National Commission for Women has approved research study on the above subject for the period of six months with the budget of Rs. 2, 37,300/-

2. The financial assistance of Rs. 2, 37,300/- (Rupees two lakhs, thirty seven thousand Three hundred only) will be released in three installments as under:

- i. 40% in advance after receipt of your acceptance to start the work;
 - ii. 40% after the collection/compilation of data and receipt of preliminary report; and

- ii. Acceptance letter to conduct the approved Research Study for the period of six months.
 - iii. Submission of revised synopsis of the proposed research study on **Ostracization of women as Witches its causes compensation to victimized women and life after**
 - iv. In the synopsis objectives of the study be clearly written, methodology clearly indicate the study area, sample size, criteria of selection of sample, tools and techniques will be used, time frame work of the study
 - v. Bio-data of the Project Director
 - vi. ECS form for depositing the amount directly to your bank account.
 - vii. Undertaking
4. You are, therefore, requested to inform us about your acceptance to start the study and enabling us to release the 1st installment. If no response is received within three weeks from the date of issue of the letter, the approval will automatically be cancelled. It may please be noted that it may take at least 4 weeks to release the 1st installment after receipt of intimation from you.
